**The Waiting Restrictions (John Street, Castleberg) (Amendment)
Order (Northern Ireland) 2013**

Made - - - - - *21st January 2013*

Coming into operation - *12th February 2013*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Waiting Restrictions (John Street, Castleberg) (Amendment) Order (Northern Ireland) 2013 and shall come into operation on 12th February 2013.

Amendment

2.—(1) The Waiting Restrictions (John Street, Castleberg) Order (Northern Ireland) 2012^(d) shall be amended in accordance with paragraphs (2) and (3).

(2) In Article 1 (citation, commencement and interpretation) for the definition of “specified hours” substitute the following—

““specified hours” means the hours between 8.30 a.m. to 4.30 p.m. and 5.00 p.m. to 6.30 p.m. on the days Monday to Friday inclusive and between 8.30 a.m. to 6.30 p.m. on Saturday;”

(3) For the Schedule substitute the Schedule set out in the Schedule to this Order.

Waiting Restriction on Monday to Friday inclusive, 8.30 a.m. to 4.30 p.m. and 5.00 p.m. to 6.30 p.m. and on Saturday, 8.30 a.m. to 6.30 p.m. — Maximum stay 1 hour; No return within 1 hour

B72 John Street, Castleberg (south side) – from a point 7 metres east of its junction with Main Street for a distance of 32 metres in an easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Waiting Restrictions (John Street, Castleberg) Order (Northern Ireland) 2012 by amending the hours of operation of the waiting restriction on John Street, Castleberg to include the hours 8.30 a.m. to 6.30 p.m. on Saturday.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
