ROAD TRAFFIC

The A90 Trunk Road (A932 Lochlands Junction, Forfar) (Prohibition of Specified Turns) Order 2010

Coming into force

15th October 2010
25th October 2010

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 1(1) of that Act, they consider it expedient to do so for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the A90 Trunk Road (A932 Lochlands Junction, Forfar) (Prohibition of Specified Turns) Order 2010 and comes into force on 25th October 2010.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or cause or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule to this Order.

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991 (c.22), Schedule 8, paragraph 70 and amended by the Scotland Act 1998 (Consequential Modifications) Order 2001 (S.I. 2001/1400)) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes.

SCHEDULE

PART 1

That length of the M90/A90 Inverkeithing—Fraserburgh Trunk Road at A932 Lochlands Junction, Forfar from a point 2 metres or thereby south of the extended south kerbline at A932 Dundee Road Junction, to a point 8 metres or thereby north of the extended south kerbline at A932 Dundee Road Junction, a distance of 10 metres or thereby.

PART 2

1. All right turns from the A932 Dundee Road northwards to the M90/A90 Inverkeithing—Fraserburgh Trunk Road.
2. All manoeuvres across the length of the M90/A90 Inverkeithing—Fraserburgh Trunk Road from the A932 Dundee Road westwards to the private access road to Loanhead.
3. All right turns from the M90/A90 Inverkeithing—Fraserburgh Trunk Road southbound to the Loanhead private access road opposite the A932 Dundee Road.
4. All right turns from the Loanhead private access road opposite the A932 Dundee Road southwards to the M90/A90 Inverkeithing—Fraserburgh Trunk Road.
5. All manoeuvres across the length of the M90/A90 Inverkeithing—Fraserburgh Trunk Road from the Loanhead private access road opposite the A932 Dundee Road eastwards to the A932 Dundee Road.
