**The A90/A92/A972 Trunk Roads (Forfar Road Junction, Dundee)
(Temporary Prohibition of Specified Turns) Order 2011**

Coming into force

7th September 2011
17th September 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the lengths of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near the said lengths of road.

In accordance with section 14(3) of that Act, they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A90/A92/A972 Trunk Roads (Forfar Road Junction, Dundee) (Temporary Prohibition of Specified Turns) Order 2011, comes into force on 17th September 2011 and ceases to have effect at midnight on 23rd October 2011.

Prohibition of use of vehicles

2. No person shall use, or permit the use of, any vehicle on the lengths of road specified in Part 1 of the Schedule so as to make any turn specified in Part 2 of the Schedule to this Order when such prohibition is identified as applying to any part or parts of the said lengths of road by means of traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991 Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

PART 1

1. That length of the M9/A90/M90 Edinburgh – Fraserburgh Trunk Road at its junction with the A92/A972 Kirkcaldy – Dundee Trunk Road.
2. That length of the A92/A972 Kirkcaldy – Dundee Trunk Road at its junction with the A929 Forfar Road, Dundee.

PART 2

1. All left turns from the eastbound M9/A90/M90 Edinburgh – Fraserburgh Trunk Road to the northbound M9/A90/M90 Edinburgh – Fraserburgh Trunk Road at the Forfar Road Junction, Dundee.
2. All right turns from the westbound A92/A972 Kirkcaldy – Dundee Trunk Road to the northbound M9/A90/M90 Edinburgh – Fraserburgh Trunk Road at the Forfar Road Junction, Dundee.
3. All right turns from the eastbound A92/A972 Kirkcaldy – Dundee Trunk Road to the southbound A929 Forfar Road, Dundee at the Forfar Road Junction, Dundee.
