ROAD TRAFFIC

**The A92 Trunk Road (Leuchars) (Temporary 30mph Speed
Restriction) Order 2013**

Made - - - - *29th August 2013*

Coming into force - - *7th September 2013*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A92 Trunk Road (Leuchars) (Temporary 30mph Speed Restriction) Order 2013, comes into force on 7th September 2013 and ceases to have effect on 8th September 2013.

Speed Restriction

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the Schedule to this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002^(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46) and S.I. 1999/1750.

Exemption

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011^(a) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A92/A972 Kirkcaldy – Dundee Trunk Road from a point 2 kilometres or thereby south of the junction with the A913 at Parbroath Crossroads to a point 2 kilometres or thereby north of the said junction with the A913, a distance of 4 kilometres or thereby.
