The A96 Trunk Road (Inverurie Road/Auchmill Road/Great Northern Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2013

Made - - - - 5th December 2013

Coming into force - - 16th December 2013

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and 152(2) of the Roads (Scotland) Act 1984(a), and of all other powers enabling them to do so.

Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Inverurie Road/Auchmill Road/Great Northern Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2013 and comes into force on 16th December 2013.

Redetermination of Means of Exercise of Public Right of Passage

2. The lengths of road in Aberdeen as specified in the Schedule to this Order, at present footways, shall become cycle track, the right of passage being exercisable on pedal cycle and foot only.

SCHEDULE

Article 2

INTERPRETATION

In this Schedule:

"Plan 01" means the plan numbered AB/NE/D5299/01 and "Plan 02" means the plan numbered AB/NE/D5299/02 both entitled "The A96 Trunk Road (Inverurie Road/Auchmill Road/Great Northern Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2013" signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow G4 0HF;

"the A96 Trunk Road" means the A96 Aberdeen – Inverness Trunk Road;

"the Haudagain Roundabout" means the junction of the M9/A90/M90 Edinburgh – Fraserburgh Trunk Road and the A96 Trunk Road;

"Sclattie Roundabout" means the junction of the A96 Trunk Road, Bankhead Avenue and Sclattie Park:

"Inverurie Road" means the detrunked length of Inverurie Road adjoining the A96 Trunk Road at both ends.

Roads over which means of exercise of public right of passage is to be redetermined - Aberdeen

- **1.** That length of the footway on the west side of the A96 Trunk Road north of Sclattie Roundabout, from where the projection of the northwest edge of the access road to Hopetoun Croft Cottage meets that footway, in a southeasterly direction to a point 14 metres or thereby north from the projected north east kerbline of Sclattie Park a distance of 68 metres or thereby, as indicated by sawtooth hatching between the points marked 'A' and 'B' on Plan 01.
- 2. That length of footway on the west side of the A96 Trunk Road south of Sclattie Roundabout, from a point on the south east edge of the carriageway of Sclattie Park 23 metres or thereby north east from where the projection of the south east edge of the carriageway of Sclattie Park meets with the projection of the southwesterly edge of the carriageway of Cloverfield Gardens, in a southeasterly direction to the point 17 metres or thereby south from where the projection of west side of the A96 Trunk Road meets with the projection of the western edge of Inverurie Road, a distance of 355 metres or thereby, as indicated by sawtooth hatching between the points marked 'C' and 'D' on Plan 01.
- **3.** The length of footway on the north side of A96 Trunk Road, from a point 12 metres or thereby north of the of the point where the projection of the A96 Trunk Road meets the projection of the east side of Gilbert Road, in an easterly direction to a point 16 metres or thereby north of the projection of the northern side of the A96 Trunk Road and the projection of the western side of Malcolm Road, a distance of 86 metres or thereby, as indicated by sawtooth hatching between the points marked 'E' and 'F' on Plan 01.
- **4.** The length of footway on the north side of A96 Trunk Road, from a point 2 metres or thereby east of the point where the projection of the east edge of Old Meldrum Road meets the projection of the north edge of A96 Trunk Road, in an easterly direction to a point 16 metres or thereby north of the point where the projection of the north edge of the A96 Trunk Road meets the west edge of the Mugiemoss Road at Haudagain Roundabout, a distance of 1605 metres or thereby, as indicated by sawtooth hatching between the points marked 'G' and 'H' on Plan 02.
