ROAD TRAFFIC

**The A83 Trunk Road (Poltalloch Street and Lochnell Street,
Lochgilphead) (Temporary Prohibition On Use of Road) Order
2015**

Made - - - - *29th October 2015*

Coming into force - - *8th November 2015*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with Section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with Section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with Section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A83 Trunk Road (Poltalloch Street and Lochnell Street, Lochgilphead) (Temporary Prohibition On Use of Road) Order 2015, comes into force on 8th November 2015 and ceases to have effect on 9th November 2015.

Prohibition on use of vehicles

2. No person may use or permit the use of any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for facilitating the holding of the relevant event.

SCHEDULE

Article 2

That length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from its junction with Lorne Street, Lochgilphead generally eastwards in Poltalloch Street and Lochnell Street to its junction with Campbell Street, Lochgilphead, a distance of 410 metres or thereby.
