ROADS AND BRIDGES

The A830 Trunk Road (Criche Bridge Improvement) (Stopping Up of Accesses) Order 2017

Made - - - - *15th June 2017*

Coming into force - - *26th June 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 69(1) of the Roads (Scotland) Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 69(1) of that Act, they consider that the private means of access from the A830 Fort William – Mallaig Trunk Road specified in the schedule is likely to cause danger to traffic on that road.

In accordance with sections 69(2) and 71(3) of that Act, they are satisfied that another reasonably convenient means of access will be provided in pursuance of this Order before the private means of access is stopped up.

Citation and commencement

1. This Order may be cited as the A830 Trunk Road (Criche Bridge Improvement) (Stopping Up of Accesses) Order 2017 and shall come into force on 26th June 2017.

Means of access to be stopped up

2. The stopping up of the private access to Arieniskill Cottage, Lochailort, PH38 4NA specified in the schedule of this Order is hereby ordered.

New means of access

SCHEDULE

Articles 2 and 3

INTERPRETATION

In this schedule—

“the plan” means the plan folio numbered 12/NW/1201/SECT69/001 entitled “The A830 Trunk Road (Criche Bridge Improvement) (Stopping Up of Accesses) Order 2017”, signed with reference to this Order and deposited at the offices of Transport Scotland, Trunk Roads and Bus Operations, Buchanan House, 58 Port Dundas Road, Glasgow G4 0HF;

“point A” means the intersecting point on the existing Criche Bridge between the centre of the watercourse and the carriageway centreline.

PRIVATE MEANS OF ACCESS TO BE STOPPED UP

The private means of access to Arieniskill Cottage, Lochailort, PH38 4NA at its junction with the A830 Fort William - Mallaig Trunk Road as shown by solid black line and marked 1 on the plan.

NEW MEANS OF ACCESS TO BE PROVIDED

From a point 85 metres or thereby east of point A, in a generally westerly direction for a distance of 116 metres or thereby, as shown by diagonal hatching and marked 2 on plan.
