ROAD TRAFFIC

**The A82 Trunk Road (Falls of Falloch) (Temporary 30mph
Speed Restriction) Order 2020**

Made - - - - *7th July 2020*

Coming into force - - *14th July 2020*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A82 Trunk Road (Falls of Falloch) (Temporary 30mph Speed Restriction) Order 2020, comes into force on 14 July 2020 and ceases to have effect on 30 September 2020.

Speed restriction

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the schedule of this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016^(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemption

3. No speed restriction imposed by this Order applies to—

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011^(a) when used in accordance with regulation 3(5) of those Regulations, or
- (b) vehicles being used in an emergency for coastguard purposes.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A82 Dalnottar-Inverness Trunk Road at Falls of Falloch from a point 800 metres or thereby south of the Falls of Falloch car park entrance to a point 800 metres or thereby north of the Falls of Falloch car park entrance, a distance of 1600 metres or thereby.
