ROAD TRAFFIC

**The A85 Trunk Road (Methven) (Temporary Prohibition on
Waiting, Loading and Unloading) (No. 2) Order 2022**

Made - - - - 27th June 2022

Coming into force - - 4th July 2022

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), 14(1)(a) and (4) and 124(1)(d) of, and paragraph 27 of schedule 9 of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A85 Trunk Road (Methven) (Temporary Prohibition on Waiting, Loading and Unloading) (No. 2) Order 2022, comes into force on 4 July 2022 and ceases to have effect on 13 August 2022.

Prohibition on waiting, loading and unloading

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or both of the traffic signs of the type described in item 19 (diagram 636 – temporary prohibition of waiting except for loading and unloading) and item 20 (diagram 636.1 – temporary prohibition of loading and unloading) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the 1991 Act, schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c. 54) (relevantly amended by S.I. 2001/1400). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c. 46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
- (b) a vehicle being used for carrying out the works.

Revocation

4. The A85 Trunk Road (Methven) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2022^(a) is revoked.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A85 Perth – Lochearnhead Trunk Road from a point 93 metres or thereby east of its junction with unclassified Road, C409, Methven in a general westerly direction along Main Street, Methven to a point 148 metres or thereby west of its junction with James Street, Methven a total distance of 1.4 kilometres or thereby.
