ROAD TRAFFIC

The A835 Trunk Road (Loch Garve) (Temporary Prohibition on Use of Road and Temporary 30mph Speed Restriction) Order 2025

Made - - - - 28th January 2025

Coming into force - - 3rd February 2025

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A835 Trunk Road (Loch Garve) (Temporary Prohibition on Use of Road and Temporary 30mph Speed Restriction) Order 2025, comes into force on 3 February 2025 and ceases to have effect on 1 September 2025.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in Part 1 of the schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 – position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(**b**).

Speed restriction

3. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in Part 2 of the schedule at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016(a).

Exemptions

- **4.** No prohibition imposed by this Order applies to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes.
 - 5. No speed restriction imposed by this Order applies to—
 - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(b) when used in accordance with regulation 3(5) of those Regulations, or
 - (b) vehicles being used in an emergency for coastguard purposes.

Articles 2 and 3

SCHEDULE SPECIFIED LENGTHS OF ROAD

Part 1

That length of the A835/A893 Tore – Ullapool Trunk Road, from a point 3.2 kilometres or thereby southeast of its junction with Stirling Drive, Garve in a generally easterly direction to a point 3.7 kilometres or thereby south east of its junction with Stirling Drive, Garve a distance of 500 metres or thereby.

Part 2

That length of the A835/A893 Tore – Ullapool Trunk Road, from a point 2.972 kilometres or thereby southeast of its junction with Stirling Drive, Garve in a generally easterly direction to a point 3.928 kilometres or thereby south east of its junction with Stirling Drive, Garve a distance of 956 metres or thereby.
