

Freedom of Information Act 2000 (FOIA)

Decision notice

Decision (including any steps ordered)

1. The complainant made a request for information relating to pregnancy loss and maternity services at Bedford Hospital. The request was made on 11 May 2022 and the Trust has failed to provide a response.
2. The Commissioner considers that the Trust has breached section 10 FOIA in the handling of this request.
3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - Provide a response to the request in compliance with FOIA.
4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 11 May 2022 the complainant made the following request for information under the FOIA for:

"I would like to request information surrounding pregnancy loss and maternity services at Bedford hospital.

I would like to know since 1st November 2020

1. How many people have required admission to hospital as a result of pregnancy loss in all forms?
 2. Of those people many people requiring admission due to pregnancy loss have been admitted to a maternity ward?
 2. How many people requiring admission due to pregnancy loss in all forms have been allowed to have their partners/support person on the ward/in the room with them?
 3. Of those people requiring admission how many have had the protocol for avoiding the maternity ward followed/not followed?
 4. How many complaints has the hospital received which relate to both pregnancy loss and location of services in relation to other maternity service?"
6. The Trust has failed to provide a response to this request.

Scope of the case

7. The complainant contacted the Commissioner on 28 June 2022 and asked him to investigate whether the Trust had complied with section 10 FOIA in the handling of this request.
8. The Commissioner has considered whether the Trust complied with section 10 FOIA in this case.

Reasons for decision

Section 10

9. Section 10(1) provides that:

"Subject to subsections (2) and (3), a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."
10. Section 1(1) provides that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

11. The request was made on 11 May 2022 and the Trust has failed to respond to the request. This is despite the Commissioner contacting the Trust on 2 and 19 July 2022 to remind it of its obligations under FOIA to respond to the request. The Commissioner therefore finds that the Trust breached section 10(1) FOIA in failing to provide a response to this request.

Right of appeal

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from: First-tier Tribunal (Information Rights)
