ROAD TRAFFIC

The A120 Trunk Road (Marks Farm Roundabout, Braintree, Essex) (Temporary 40 Miles Per Hour and 50 Miles Per Hour Speed Restriction) Order 2011

Made - - - - *18th July 2011*

Coming into force - - *25th July 2011*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A120 Trunk Road (“the A120”), is satisfied that traffic on a length of that road in the County of Essex should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984^(a) hereby makes the following Order:-

1. This Order may be cited as the A120 Trunk Road (Marks Farm Roundabout, Braintree, Essex) (Temporary 40 Miles Per Hour and 50 Miles Per Hour Speed Restriction) Order 2011 and shall come into force on 25th July 2011.

2. Subject as mentioned in articles 3 and 4 of this Order no person shall, during a period of 10 hours starting at 20:00 hours on Monday 1st August 2011 or on any subsequent day until works to widen the approaches to Marks Farm Roundabout have been completed, cause or permit any vehicle to be driven on the A120 at a speed exceeding -

- (i) 50 miles per hour between its junctions with Galleys Corner Roundabout and Marks Farm Roundabout, or
- (ii) 40 miles per hour between points 400 metres south and 300 metres east of its junction with Marks Farm Roundabout.

3. The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle being used for police, fire and rescue authority or ambulance purposes.

4. The provisions of article 2 of this Order shall not apply to any vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011^(b) when used in accordance with regulation 3(5) of those Regulations.

5. The A120 Trunk Road (Marks Farm Roundabout, Braintree, Essex) (Temporary 40 Miles Per Hour Speed Restriction) Order 2011^(c) is hereby revoked.
