ROAD TRAFFIC

The M1 Motorway (Junction 15) (Temporary Restriction and Prohibition of Traffic) (No.2) Order 2012

 Made
 10th August 2012

 Coming into force
 17th August 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the M1 Motorway ("the M1") and connecting roads, is satisfied that traffic on a length of that motorway and one of those connecting roads in the County of Northamptonshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) and (7) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorway Traffic (England and Wales) Regulations 1982(b) and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the M1 Motorway (Junction 15) (Temporary Restriction and Prohibition of Traffic) (No. 2) Order 2012 and shall come into force on 17th August 2012.

2. In this Order -

"the motorway"

means the northbound carriageway of the M1 from the centreline of Courteenhall East Lodge overbridge to a point 200 metres north of the centreline of Maple Farm access overbridge, north of Junction 15;

"the slip road"

means the slip road leading to the northbound carriageway of the M1 at Junction 15;

"the Regulations"

means the Motorways Traffic (England and Wales) Regulations 1982(b);

means the hard shoulder, within the meaning of Regulation 3(1)(e) of the Regulations, which is adjacent to the motorway;

"the works period"

means the period starting at 20.00 hours on Wednesday 22nd August 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour in the motorway.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the motorway or the slip road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of -
 - (a) article 3 shall not apply to any vehicle being used for special forces purposes;
 - (b) articles 3 and 4 shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable; and
 - (c) article 4 shall not apply to any vehicle being used for or in connection with the said works or by, or with the permission of a traffic officer.
- **7.** During the works period, regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Regulations are hereby suspended in respect of a hard shoulder, at such times and to such extent as may from time to time be indicated by traffic signs.
