The Huntingdonshire (Electoral Changes) Order 2012

Made - - - - *10th January 2012*

Coming into force in accordance with article 1(2)

Under section 92(2) of the Local Government and Public Involvement in Health Act 2007(a) (“the 2007 Act”) Huntingdonshire District Council made recommendations to the Local Government Boundary Commission for England(b) for the related alteration of the boundaries of county electoral divisions within the Council’s area.

The Local Government Boundary Commission for England has decided to give effect to the recommendations and in exercise of the powers conferred by section 92(3) of the 2007 Act makes the following Order:

Citation and commencement

- 1.—(1) This Order may be cited as the Huntingdonshire (Electoral Changes) Order 2012.
- (2) This Order comes into force—
 - (a) for the purpose of proceedings preliminary or relating to the elections of councillors for county electoral divisions, on 15th October 2012;
 - (b) for all other purposes, on the ordinary day of election of councillors in 2013.

Interpretation

2. In this Order—

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983(c);

“the 2009 Order” means the Huntingdonshire (Parishes) Order 2009(d).

(b) The Local Government Boundary Commission for England was established on 1st April 2010 by section 55(1) of the 2009 Act (c.20). The functions of the Electoral Commission under Chapter 3 of Part 4 of the Local Government and Public Involvement in Health Act 2007 (c.28) (“the 2007 Act (c.28)”) were transferred under section 60 of the 2009 Act (c.20) to the Local Government Boundary Commission for England on 1st April 2010.

(c) 1983 c.2. Section 37 has been amended by section 18(2) of the Representation of the People Act 1985 (c.50), section 17 of the Greater London Authority Act 1999 (c.29) and section 60 of the 2007 Act (c.28).

(d) The Huntingdonshire (Parishes) Order 2009 (S.I. 2009/2091) was made by the Secretary of State under sections 14 and 23 of the Local Government and Rating Act 1997 (c.29).

Related alterations of county electoral division boundaries

3.—(1) Each area described in column 1 of the Schedule ceases to be part of the county electoral division named in column 2 of that Schedule and becomes part of the county electoral division named in column 3 of that Schedule.

(2) In this article “county electoral division” means an electoral division established by the County of Cambridgeshire (Electoral Changes) Order 2005^(a).

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by Huntingdonshire District Council to the Local Government Boundary Commission for England for related alterations of county electoral division boundaries. These alterations are related to parish boundary changes made by the Huntingdonshire (Parishes) Order 2009. The functions of the Electoral Commission relating to boundary change were transferred to the Local Government Boundary Commission for England on 1st April 2010.

The new boundaries apply in respect of county elections to be held on and after the ordinary day of election of councillors in 2013.

Article 3 alters Brampton and Kimbolton; Buckden, Gransden and The Offords; Huntingdon; Little Paxton and St Neots North; Ramsey; Sawtrey and Ellington; Somersham and Earith; St Ives; St Neots Eaton Socon and Eynesbury; The Hemingfords and Fenstanton and Warboys and Upwood county electoral divisions.

An impact assessment has not been produced for this instrument as no impact on the private or voluntary sectors is foreseen.
