**ROAD TRAFFIC**

**The A1(M) Motorway (Junction 38, Redhouse) (Temporary Prohibition of Traffic) Order 2013**

*Made* - - - *6th June 2013*

*Coming into force* - *16th June 2013*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway, the A638 Trunk Road and connecting roads, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on that trunk road and some of those connecting roads should be prohibited because carriageway improvements and lighting works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

**1.** This Order may be cited as the A1(M) Motorway (Junction 38, Redhouse) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 16th June 2013.

**2.** Subject as mentioned in article 3 of this Order, no person shall, during a period starting at 00:01 hours on Monday 17th June 2013 and ending when the said works have been completed, cause or permit any vehicle to enter or proceed in the:

- (i) A1 Trunk Road southbound exit slip road and the A638 Trunk Road leading to the A638 eastbound carriageway at Junction 38 (Redhouse) and its junction with the A638 roundabout at Redhouse Interchange;
- (ii) A638 Trunk Road from its junction with the A638 roundabout at Redhouse Interchange and the A1(M) Motorway southbound entry slip road at Junction 38; or
- (iii) A1(M) Motorway northbound exit slip road leading to the A638 westbound carriageway or the northbound entry slip road leading from the A638 westbound carriageway at Junction 38.

**3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 2 shall apply to any vehicle proceeding in the A638 Trunk Road or a slip road to or from premises and property which is accessible for that vehicle from, and only from, those roads.
