**The Air Navigation (Restriction of Flying) (Jet Formation  
Display Team, County Londonderry) Regulations 2014**

*Made* - - - - *10th June 2014*

*Coming into force* - - *29th June 2014*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in specified airspace within County Londonderry, Northern Ireland by reason of a flying display by a jet formation display team to be held on 29th June 2014 in the vicinity of Inishowen Head in County Donegal (Republic of Ireland).

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

**Citation and commencement**

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Jet Formation Display Team, County Londonderry) Regulations 2014 and come into force on 29th June 2014.

**Interpretation**

2. In regulation 3 all times referred to are Co-ordinated Universal Time(b).

**Restricted airspace**

3.—(1) Subject to paragraph (3), between 1345 hours and 1445 hours, on 29th June 2014, no aircraft is to fly below 9,000 feet above mean sea level within so much of the restricted airspace mentioned in paragraph (2) as constitutes United Kingdom airspace.

(2) The restricted airspace is airspace from the surface to 9,000 feet above mean sea level within the area bounded successively by—

- (a) the clockwise arc of a circle having a radius of 6 nautical miles whose centre is at 551204N 0065724W between 551803N 0065744W and 551056N 0070741W, and
- (b) a straight line joining the points 551056N 0070741W and 551803N 0065744W.

(3) Paragraph (1) does not apply to any aircraft flying in accordance with a clearance issued by the air traffic control unit at City of Derry Airport.

(b) Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations impose restrictions on flying within airspace in County Londonderry, Northern Ireland, during a flying display by the Royal Air Force Aerobatic Team, the Red Arrows, that is scheduled to take place on 29th June 2014 nearby, in the vicinity of Inishowen Head, County Donegal (Republic of Ireland).

In order to protect the display aircraft, other air traffic and spectators, it is considered that flying should be restricted in the United Kingdom part of the airspace within which the display team will perform. This has been agreed with the Department for Transport.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time.

Full details of the restricted airspace will also be published by NOTAM.
