**The Immigration (Designation of  
Travel Bans) (Amendment) Order 2014**

The Secretary of State makes the following Order in exercise of the power conferred by section 8B(5) of the Immigration Act 1971<sup>(1)</sup>.

1. This Order may be cited as the Immigration (Designation of Travel Bans) (Amendment) Order 2014 and comes into force on 21st July 2014.
2. For the Schedule to the Immigration (Designation of Travel Bans) Order 2000<sup>(2)</sup> substitute the Schedule set out in Schedule 1 to this Order.
3. The instruments listed in Schedule 2 to this Order are revoked.

Any person named by or under an instrument listed in the new Schedule or falling within a description in such an instrument will be excluded from the United Kingdom (subject to the exceptions specified in article 3 of the 2000 Order).
