ROAD TRAFFIC

**The M4 Motorway and the A34 Trunk Road (M4 Junction 13)
(Temporary Prohibition of Traffic) Order 2014**

Made - - - - - *15th September 2014*

Coming into force - - - - - *4th October 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M4 Motorway and the A34 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on lengths of these roads and some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M4 Motorway and the A34 Trunk Road (M4 Junction 13) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 4th October 2014 and shall apply for a period of eighteen months.

2. In this Order:

“the motorway” means the M4 Motorway in the County of Berkshire;

“the trunk road” means the A34 Trunk Road in the County of Berkshire;

“a slip road” means –

- (i) the road leading from the northbound carriageway of the trunk road at Chieveley Interchange (motorway Junction 13),
- (ii) the road leading to the southbound carriageway of the trunk road at Chieveley Interchange (motorway Junction 13),
- (iii) the road leading to the northbound carriageway of the trunk road at Chieveley Interchange (motorway Junction 13),
- (iv) the road leading from the southbound carriageway of the trunk road at Chieveley Interchange (motorway Junction 13),
- (v) the road leading to the westbound carriageway of the motorway at Junction 13 (Chieveley Interchange),
- (vi) the road leading from the eastbound carriageway of the motorway at Junction 13 (Chieveley Interchange),
- (vii) the road leading from the westbound carriageway of the motorway at Junction 13 (Chieveley Interchange),

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- (viii) the road leading to the eastbound carriageway of the motorway at Junction 13 (Chieveley Interchange),
- (ix) the road leading to Graces Lane at Chieveley Interchange (motorway Junction 13),
- (x) the road leading from Graces Lane at Chieveley Interchange (motorway Junction 13),
- (xi) the road leading from Whitefield Cottages at Chieveley Interchange (motorway Junction 13),
- (xii) the road leading to Whitefield Cottages at Chieveley Interchange (motorway Junction 13),
or
- (xiii) the road leading to the Chieveley Services at Chieveley Interchange (motorway Junction 13);

“a section of roundabout” means –

- (i) the western section of the motorway Junction 13 roundabout (Chieveley Interchange) between the southbound slip road to the trunk road and the southbound slip road from the trunk road, or
- (ii) the eastern section of the motorway Junction 13 roundabout (Chieveley Interchange) between the northbound slip road to the trunk road and the northbound slip road from the trunk road;

“works” mean resurfacing, reinstatement of road markings and studs and all associated carriageway works; and

“a works period” means a period of 8 hours starting at 2200 hours on Monday 6th October 2014 or on any subsequent day until 3rd April 2016.

3. Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road or a section of roundabout.

4. The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) any vehicle being used for winter maintenance purposes;
- (d) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (e) a vehicle proceeding in a slip road or a section of roundabout to or from premises accessible from, and only from, that road to such extent as shall be indicated by traffic signs.
