**The A45 Trunk Road (Stonebridge Highway, Coventry)
(Temporary Prohibition of Traffic) Order 2014**

Made - - - - *24th January 2014*
Coming into force - - *31st January 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road (“the A45”), is satisfied that traffic on lengths of that road at Coventry should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and section 15(2) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A45 Trunk Road (Stonebridge Highway, Coventry) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 31st January 2014.

2. In this Order:

| “Tollbar End Roundabout” | means the circulatory carriageway of the A45 at its roundabout junction with the B4110, A46 and Siskin Drive; |
| “the trunk road” | means the eastbound and westbound carriageways of the A45 between a point 130 metres west of its roundabout junction with the A444 and A46 (Stivichall Roundabout) and Tollbar End Roundabout; |
| “pedal cycle” | has the meaning given in regulation 4 of the Traffic Signs Regulations and General Directions 2002; |
| “cycle track” | means a way constituting or comprised in a highway, being a way over which the public have the following, but no other, rights of way, that is to say, a right of way on pedal cycles with or without a right of way on foot; |
| “footway” | means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only; |

“the footway/cycle track”	means the segregated footway/cycle track situated – i) adjacent to the eastbound carriageway of the A45 from a point 200 metres west of its junction with Stonehouse Lane to Tollbar End Roundabout; ii) across Tollbar End Roundabout; and iii) adjacent to the north westerly section of Tollbar End Roundabout, between the eastbound and westbound carriageways of the A45;
“overall width”	has the same meaning given in regulation 3(2) of the Road Vehicles (Construction and Use) Regulations 1986 (a)
“the works period”	means the period starting at 00:01 hours on Monday 3rd February 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any person using a pedal cycle to enter or proceed in the footway/cycle track.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any pedestrian to enter or proceed in the footway/cycle track.

5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle with an overall width exceeding –

- i) 3.0 metres to enter or proceed in the nearside lane (Lane 1) of the trunk road; and
- ii) 2.75 metres to enter or proceed in the offside lane (Lane 2) of the trunk road.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

7. The provisions of articles 3 and 4 shall not apply to any person -

- (a) engaged in police, fire brigade or ambulance activity; or
- (b) engaged in activity connected with the said works.

8. The provisions of article 5 shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable in uniform; or
- (c) being used for or in connection with the said works.

9. The Secretary of State is satisfied that the execution of the said works will take longer than a period of eighteen months starting on the date when this Order comes into force.
