ROAD TRAFFIC

The A303 Trunk Road and A36 Trunk Road (Deptford Junction Slip Roads) (Temporary Prohibition of Traffic) (Number 2) Order 2014

Made - - - - 16th December 2014

Coming into force - - 18th December 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A303 Trunk Road ("the A303"), the A36 Trunk Road ("the A36") and connecting roads, is satisfied that traffic on one of those connecting roads at the Deptford Junction in Wiltshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A303 Trunk Road and A36 Trunk Road (Deptford Junction Slip Roads) (Temporary Prohibition of Traffic) (Number 2) Order 2014 and shall come into force on 18th December 2014.

2. In this Order –

"the slip road" mean (i) the A36 southbound exit slip road at Deptford from a point 124 metres west of the centre of the junction with the minor road to Deptford village to the western edge of that junction and (ii) the A303 eastbound entry slip road from the eastern edge of the junction with the minor road to Deptford village to the tip of the nosing of the eastbound entry slip road at the A303 / A36 Deptford Junction;

"the tip of the nosing" means the first point where an entry slip road joins the carriageway of a trunk road or the last point where an exit slip road leaves the carriageway of a trunk road;

"the works" mean carriageway investigations;

"a works period" means a period of 10 hours starting at 20.00 hours on Monday 5th January 2015 and at the same time on subsequent days ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during a works period, cause or permit any vehicle to enter or proceed on the slip road.

- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;
 - (b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
 - (c) a vehicle being used in connection with the said works or for winter maintenance purposes.
