**The Air Navigation (Restriction of Flying) (Duxford)
Regulations 2021**

Made - - - - - *5th May 2021*

Coming into force - - - - - *23rd July 2021*

The Secretary of State has decided that it is in the public interest to restrict flying in the vicinity of Duxford Aerodrome, Cambridgeshire, by reason of the holding of flying displays.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Duxford) Regulations 2021 and come into force on 23rd July 2021.

Interpretation

2. In regulation 3(2) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (3), and during the periods specified in paragraph (2), no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by a circle having a radius of 2.2 nautical miles whose centre is at 520539N 0000753E.

(2) The periods referred to in paragraph (1) are—

- (a) between 0800 hours and 1700 hours on 23rd July 2021,
- (b) between 1100 hours and 1700 hours on 24th and 25th July 2021,
- (c) between 0800 hours and 1700 hours on 17th September 2021, and
- (d) between 1100 hours and 1700 hours on 18th and 19th September 2021.

(3) Paragraph (1) does not apply to any aircraft flying in accordance with a permission issued by the Duxford Aerodrome flying display director.

(a) S.I. 2016/765, to which there are amendments not relevant to these Regulations.
(b) Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Duxford Aerodrome, Cambridgeshire, during air displays that are scheduled to take place there on 23rd, 24th and 25th July 2021 and 17th, 18th and 19th September 2021. A large number of aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety.

The times mentioned in regulation 3(2) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(3), the Duxford Aerodrome flying display director may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Airmen (NOTAM).
