**The Air Navigation (Restriction of Flying) (Remembrance
Sunday) Regulations 2022**

Made - - - - - *6th September 2022*

Coming into force - - - - - *13th November 2022*

The Secretary of State has decided that it is in the public interest to restrict flying in the area specified in regulation 3(1) by reason of the holding there of the Remembrance Sunday ceremony at the Cenotaph.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Remembrance Sunday) Regulations 2022 and they come into force on 13th November 2022.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1000 hours and 1230 hours on 13th November 2022 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by a circle having a radius of 2.5 nautical miles whose centre is at 513009N 0000734W.

(2) Paragraph (1) does not apply to any aircraft—

- (a) operating by or on behalf of—
 - (i) the National Police Air Service,
 - (ii) the Helicopter Emergency Medical Service,
 - (iii) the Maritime and Coastguard Agency,
- (b) flying in accordance with the permission of the Metropolitan Police Service, or
- (c) making an approach to Runway 09 at London City Airport—
 - (i) whilst under the control of the air traffic control unit at London City Airport or London Terminal Control, Swanwick, and

(a) S.I. 2016/765, to which there are amendments not relevant to these Regulations.

(b) Co-ordinated Universal Time (UTC) is the same as Greenwich Mean Time (GMT).

- (ii) at a height of not less than 1,500 feet above mean sea level and to the east of a line running true north to true south through 513030N 0000514W (London Bridge).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying above Central London during the Remembrance Sunday ceremony at the Cenotaph which is scheduled to take place there on 13th November 2022. The Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety and security.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is the same as Greenwich Mean Time (GMT).

In relation to the permission mentioned in regulation 3(2)(b), the Metropolitan Police Service may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Notice to Aviation (NOTAM).
