**The Air Navigation (Restriction of Flying) (Balmoral to
Edinburgh) (Amendment) Regulations 2022**

Made - - - - *10th September 2022*

Coming into force - - *11th September 2022*

The Secretary of State has previously decided that it is necessary in the public interest to restrict flying in certain areas by reason of arrangements associated with the death of Her late Majesty Queen Elizabeth II and now considers it necessary in the public interest to change the specific times of these restrictions.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016^(a).

Citation and commencement

1. These Regulations may be cited as The Air Navigation (Restriction of Flying) (Balmoral to Edinburgh) (Amendment) Regulations 2022 and they come into force on 11th September 2022.

Amendment of the Regulations

2. The Air Navigation (Restriction of Flying) (Balmoral to Edinburgh) Regulations 2022^(b) are amended as follows—

- (a) in regulation 3(2) for “0930 hours and 1100 hours” substitute “0900 hours and 1215 hours”,
- (b) in regulation 3(3) for “1030 hours and 1130 hours” substitute “0945 hours and 1230 hours”,
- (c) in regulation 3(4) for “1100 hours and 1230 hours” substitute “1000 hours and 1330 hours”,
- (d) in regulation 3(5) for “1145 hours and 1345 hours” substitute “1040 hours and 1500 hours”,
- (e) in regulation 3(6) for “1315 hours and 1415 hours”, substitute “1200 hours and 1540 hours”,
- (f) in regulation 3(7) for “1340 hours and 1500 hours”, substitute “1240 hours and 1615 hours”,
- (g) in regulation 3(8) for “1415 hours and 1615 hours”, substitute “1315 hours and 1700 hours”, and

(a) S.I. 2016/765, to which there are amendments not relevant to these Regulations.

(b) S.I. 2022/953.

(h) in regulation 3(9) for “1500 hours and 1845 hours on 11th September 2022”, substitute 1400 hours on 11th September 2022 and 2359 hours on 13th September 2022”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Air Navigation (Restriction of Flying) (Balmoral to Edinburgh) Regulations 2022 (S.I. 2022/953). They amend the specific times of the restrictions applying on 11th September 2022 and extend the restriction over Edinburgh from 1845 hours on 11th September to 2359 hours local time on 13th September 2022.

Full details of this Statutory Instrument will be promulgated by Notice to Aviation (NOTAM).
