**The Air Navigation (Restriction of Flying) (East Kirkby)
Regulations 2023**

Made - - - - *12th June 2023*

Coming into force - - *5th August 2023*

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of aircraft in the area specified in regulation 3(1) by reason of the intended holding there of flying displays associated with the East Kirkby Air Show.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (East Kirkby) Regulations 2023 and they come into force on 5th August 2023.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1130 hours and 1630 hours on 5th August 2023 no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by a circle having a radius of 2 nautical miles centred at 530811N 0000019E.

(2) Paragraph (1) does not apply to any aircraft—

- (a) flying in accordance with a permission issued by the East Kirkby Air Show flying display director, or
- (b) making an approach to or departure from Royal Air Force Coningsby whilst under the direction of the air traffic control unit at Royal Air Force Coningsby.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of East Kirkby, Lincolnshire during air displays that are due to take place there on 5th August 2023.

Many aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), the East Kirkby Air Show flying display director may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Briefing Sheet and Notice to Aviation (NOTAM).
