*Mr. Attlee to Monsieur Michiels van Verduynen*

Your Excellency, *Foreign Office, 6th September, 1949.*

I HAVE the honour to propose to your Excellency that in pursuance of the arrangements discussed between the representatives of the two Governments in London, the Monetary Agreement of the 7th September, 1945<sup>(1)</sup>, between the Government of the United Kingdom of Great Britain and Northern Ireland and the Royal Netherlands Government which under Article 12 thereof was due to expire on 7th September, 1948, but was renewed for one year and modified by Notes exchanged on 6th September, 1948<sup>(2)</sup>, between Mr. Bevin and your Excellency shall be continued as modified by those letters for a further period of one year from 7th September, 1949.

2. If the Royal Netherlands Government agree to these proposals, I have the honour to suggest that the present Note and your reply in that sense shall be regarded as constituting an Agreement between the two Governments.
