Your Excellency,

Foreign Office, S.W. 1, July 13, 1959.

I have the honour to refer to the Agreement, constituted by the Exchange of Notes of the 6th and 12th of August, 1946,⁽²⁾ as modified by the Notes exchanged on the 3rd of July, 1947,⁽³⁾ between the Government of the United Kingdom of Great Britain and Northern Ireland and the Hungarian Government regarding payments between the United Kingdom and Hungary.

2. As most of the provisions of the Annex to the aforesaid Agreement are now obsolete I hereby give notice, in accordance with the terms of paragraph 11 of the said Annex, of termination of the said Agreement with effect from the expiry of 60 days after the date of the present Note; provided that the Hungarian Government acknowledge that the termination shall in no way affect the rights of bondholders and any other persons whose claims are not covered by the Agreement of the 27th of June, 1956, relating to the Settlement of Financial Matters.

3. At the same time as requesting Your Excellency to be so good as to acknowledge receipt of this notice of termination of the above-mentioned Agreement, I propose that the present Note and Your Excellency's acknowledgment thereof, confirming the Hungarian Government's acceptance of the foregoing proviso, shall be regarded as constituting an Agreement between the two Governments in this matter.
