Your Excellency

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Kingdom of Thailand for the Promotion and Protection of Investments signed at London on 28 November 1978⁽¹⁾ and, in accordance with the provisions of Article I, to propose that the Agreement shall extend to the Bailiwick of Guernsey, Jersey and the Isle of Man.

If this proposal is acceptable to the Government of the Kingdom of Thailand, I have the honour to suggest that the present Note and Your Excellency's reply to that effect shall constitute an Agreement between the two Governments which shall enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to extend to Your Excellency the assurance of my highest consideration.
