EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES TO AMEND THE TREATY ON MUTUAL LEGAL ASSISTANCE IN CRIMINAL MATTERS BETWEEN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE REPUBLIC OF THE PHILIPPINES, DONE AT LONDON ON 18 SEPTEMBER 2009

Her Britannic Majesty's Embassy presents its compliments to the Department of Foreign Affairs of the Republic of the Philippines and has the honour to refer to previous discussions, initiated in September 2013 and including discussion at the UK/Philippines High Level Political Talks on 21 November 2013, proposing a technical amendment to the Treaty on Mutual Legal Assistance in Criminal Matters between the United Kingdom of Great Britain and Northern Ireland and the Republic of the Philippines.

Article 3, paragraph 6 of the Treaty on Mutual Legal Assistance in Criminal Matters between the United Kingdom of Great Britain and Northern Ireland and the Republic of the Philippines states " The Contracting States may, at any time, designate any other authority as a Central Authority for the purposes of this Treaty. Notification of such a designation will take place by exchange of diplomatic notes."

The Embassy wishes to inform the Department that the Government of the United Kingdom of Great Britain and Northern Ireland wishes to amend the designated Central Authority for the purposes of this Treaty and proposes that paragraphs 2 and 3 of Article 3 be amended as follows:

"2. For the United Kingdom, the Central Authorities for the purposes of sending requests shall be:

- (a) the United Kingdom Central Authority; and
- (b) the Lord Advocate (for matters pertaining to Scotland).

3. For the United Kingdom, the Central Authorities for the purpose of receiving requests shall be:

- (a) the United Kingdom Central Authority;
- (b) the Lord Advocate (for matters pertaining to Scotland); and/or
- (c) Her Majesty's Revenue and Customs.”

The Government of the United Kingdom of Great Britain and Northern Ireland further proposes that this Note and the reply Note from the Government of the Philippines accepting this proposal shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Philippines, which shall enter into force on the date of the Notification sent by the Government of the Philippines to the Government of the United Kingdom of Great Britain and Northern Ireland. The Embassy attaches a draft reply Note for the Department's consideration.

The Embassy is keen to see the proposed technical amendment to the Treaty agreed to in order to facilitate the growing cooperation between the respective law enforcement agencies in our two countries. The effect of this change will be to allow the Government of the United Kingdom to respond more quickly to requests from the Government of the Republic of the Philippines for Assistance.

Her Britannic Majesty's Embassy avails itself of this opportunity to renew to the Department of Foreign Affairs of the Republic of the Philippines the assurances of its highest consideration.
