The Welsh Ministers, in exercise of the power conferred by section 241(3) of the Planning Act 2008<sup>(1)</sup>, make the following Order:

**Title**

1. The title of this Order is the Planning Act 2008 (Commencement No. 3) (Wales) Order 2014.

**Provision coming into force on 28 November 2014**

2. Section 198 of the Planning Act 2008 (so far as it is not yet in force) comes into force in relation to Wales on 28 November 2014.
